为提高对贷款指令的处理效率、防范操作及道德风险,渣打银行(中国)有限公司(以下均称"渣打银行"或"银行")在企业和金融机构客户提交贷款提款指令、提款支持性文件、循环贷款申请、还款指令、提前还款指令方面有如下变动及安排。该变动将于 2015 年 1 月 1 日起生效。To improve efficiency and to avoid ethic and operational risk, Standard Chartered Bank (China) Limited ("SCB") will make a few changes to current loan drawdown, loan rollover, repayment and prepayment instruction ("Loan Instructions") submission process. The new process takes effect from 1st January 2015.

自生效之日起,对于企业和金融机构客户而言,渣打银行将只接受通过以下几种方式提交贷款提款指令、提款支持性文件、循环贷款申请、还款指令及提前还款指令(以下一并称"贷款指令")。 SCB will only accept Loan Instructions submitted through the following way:
