

## **Business Platinum Credit Card Sign-Up Gift Promotion Terms and Conditions**

1. This **Business Platinum Credit Card Sign-Up Gift Promotion** (the "**Promotion**") is available from 1 August 2016 to 31 March 2017 (both dates inclusive) (the "**Promotion Period**"), unless otherwise extended or terminated in accordance with these terms. This Promotion is open to all employees of a participating company (the "EB Company") in the Employee Banking Programme of Standard Chartered Bank (Singapore) Limited (the "Bank"), subject to these terms. By participating in the Promotion, you agree to be bound by these terms and conditions.

## **ELIGIBILITY**

- 2. In order to qualify for this Promotion (as an "Eligible Customer"), you must satisfy all the qualifying criteria:
  - a. you must apply for the Business Platinum Credit Card issued by Standard Chartered Bank (Singapore) Limited ("Bank") as a
    principal cardholder during the Promotion Period through the Bank's Employee Banking Programme, using the application
    forms and envelopes provided by the Bank and marked with an identifiable Employee Banking code;
  - b. the Bank must receive your application for the Business Platinum Credit Card ("Eligible Product") no later than 30 April 2017;
  - c. your application for the Eligible Product must be approved by the Bank;
  - d. the Business Platinum Credit Card account must be validly existing (i.e. must not be suspended, cancelled or terminated), in good standing, and conducted in a proper and satisfactory manner at all times, including the time of delivery and/or collection of any Gift (as defined below), as determined by the Bank in its sole and absolute discretion; and

## **SIGN-UP GIFT**

- 3. If you satisfy the qualifying criteria set out in **Clause 2** above, you will be eligible to receive an approval gift (the "Gift") of the Bank's choice (which may vary from time to time at the Bank's sole discretion) subject to these terms.
- 4. Redemption letters for the Gift (the "Gift") will be sent to you within 60 days of your application approval date, whichever is later.
- 5. The Gifts are provided by third party merchants. The Bank is not an agent of the merchants supplying the Gifts. The Bank makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Gifts and assume no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in the Gifts. Any dispute about the quality, value, condition or performance of the Gifts is to be resolved directly with the merchants. The Bank is not obliged to assist or act on your behalf in communicating with the merchants supplying the Gifts for any reason. You accept the Gifts as it is and subject to any terms and conditions the merchants may impose. No payment or compensation whether in cash, credit or kind shall be made for any uncollected, lost, misplaced, defaced, stolen or damaged Gifts.
- 6. For the avoidance of doubt, you are only eligible to receive a maximum of one (1) Gift for the Promotion, and the Gifts are available only on a first-come, first-served basis, while stocks last.
- 7. The Gifts are non-redeemable for cash, credit and/or any other items. The Gifts are strictly non-transferable, non-assignable and non-exchangeable, whether in full or in part. The Bank may replace or substitute the Gifts with any item of equivalent or similar value, without prior notice or reason.
- 8. The Bank reserves the right to debit the value of the Gifts and/or forfeit any Gifts without compensation, if you terminate the Business Platinum Credit Card account for any reason following the delivery and/or collection of the Gifts and/or if the Business Platinum Credit Card account is not valid, subsisting and/or in good standing at the time of delivery and/or collection of the Gifts, as determined at the Bank's sole and absolute discretion.

## **GENERAL**

- 9. Unless otherwise stated, this Promotion is not valid with other offers, discounts, rebates, vouchers, privileges or promotions.
- 10. The Bank reserves the right to vary, modify, add, delete or otherwise revise any of these terms and conditions or to terminate, withdraw, extend or shorten the Promotion at any time at the Bank's sole discretion, with or without prior notice or reason.
- 11. The Bank reserves the right to determine at its sole and absolute discretion all matters arising out of or in connection with the Promotion, including your eligibility for the Gifts and/or the Promotion. The Bank's determination of all matters relating to this Promotion, including but not limited to, your eligibility to participate in the Promotion and/or receive any Gifts, shall be final and binding and no correspondence will be entertained.



- 12. These terms and conditions are to be read in conjunction with the Credit Card Terms, Standard Chartered Employee Banking Programme Terms and Conditions, (collectively, the "Other Terms"). In the event of any inconsistency between these terms and the Other Terms, these terms shall, to the extent of such inconsistency, prevail.
- 13. A person who is not a party to these terms and conditions has no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any of these terms and conditions.
- 14. These terms and conditions are governed and construed in accordance with the laws of Singapore. Any dispute arising out of these terms and conditions shall be referred to the exclusive jurisdiction of the Courts of Singapore.
