Remarks:

The directors intend to cancel the shares purchased pursuant to the authority granted by the special resolution. The special resolution refers to resolution 23 approved by the issuer's shareholders at its annual general meeting held on 7 May 2026. That resolution authorises the issuer to make purchases of its ordinary shares (subject to certain conditions) until the end of its 2027 annual general meeting (or, if earlier, until the close of business on 6 August 2027), but during that period the issuer may agree to purchase shares where the purchase may not be completed (fully or partly) until after the authority ends, so as to enable the issuer to make a purchase of ordinary shares in accordance with any such agreement as if the 2026 authority had not ended.
