7. Any dispute in connection with Star Program shall be referred to and resolved by Grameenphone Ltd. and Standard Chartered Bank shall not be a party to any such dispute at any time.
8. This Standard Chartered – Grameenphone Co-brand Credit Card Terms and Conditions shall be an integral part of the Credit Card Agreement and read in conjunction with the "Credit Card Terms and Conditions" and in case of any conflict between these two the later shall prevail.
