

Hua Ho Prosperous Sweep Promotion ("this Promotion") Terms and Conditions ("these Terms and Conditions"):

1. Term

1.1 This Promotion begins on 9 to 28 February 2018 ("Promotion Period").

2. Eligibility & Benefits

- 2.1 Supermarket Prosperous Sweep
- 2.1.1 Standard Chartered MasterCard cardholders who spend BN60 in a single receipt at Participating Outlets during the Promotion Period will be eligible for a chance to participate in the Supermarket Prosperous Sweep.
- 2.1.2 A 'Standard Chartered MasterCard Credit Card' may consist of any of the following types

2.1.4 Any transactions reversal will be excluded from this Promotion.

- 2.1.5 Subject to these Terms and Conditions, six (6) winners will be selected based on their cumulative number of chances by a computerised system from the pool of eligible entries on the draw date. These winners will be contacted two (2) weeks after the end of the Promotion Period to attend the Supermarket Prosperous Sweep event at Hua Ho Manggis Mall Supermarket.
- 2.1.6 Winners will be notified of the date of the event by SMS and/or telephone at their phone numbers in our records only.
- 2.1.7 All winners must be present at the event in order to be eligible to participate. Alternatively, they may appoint a representative to participate on their behalf by providing a letter of authorisation and a copy of their Identification Document. Failure to be present will result in the winner forfeiting the prize.
- 2.1.8 The six (6) winners will have up to two (2) minutes to select their items and carry them to the cashier counter after which the items will be scanned and totalled up.
- 2.1.9 Each winner may only have a maximum quantity of six (6) for each item.
- 2.1.10 Each winner may only walk away with up to BND600 worth of supermarket items. Should the total amount exceed the allowed maximum, the winner may have the option to pay for the excess or return the item accordingly.

- 4.4 In the case of any disputes arising from or in connection with this Promotion, our decision is final and conclusive.
