The Final Terms dated 16 August 2016 relating to the issue by Standard Chartered PLC on 19 August 2016 of US\$1,000,000,000 2.100 per cent. Senior Unsecured Fixed Rate Notes due 2019, US\$750,000,000 Senior Unsecured Floating Rate Notes due 2019 and US\$1,250,000,000 4.300 per cent. Dated Subordinated Notes due 2027 (together, the “Notes”) have been submitted to the UK Listing Authority and are available for viewing.
