> Rp500 Juta	7.00%	6.00%

**Change in the Counter Rate of Savings and Current Account**

*Dear Valued Customer,*

*Based on the Auction Result of 12-Months Bank Indonesia Deposit Certificate (SDBI) on 25 August 2017 whereby the interest rate of 12-Months SDBI is decreased, therefore, in accordance with the Financial Services Authority (OJK) Regulation concerning the Maximum Interest Rate Capping, adjustment to the counter rate of Saving and Current Account (Counter Rate) have been made and **effective as of 28 August 2017**.*

*The changes are as follows:*

Tiering	Premium Saving* (Prior 28 Aug 2017)	Premium Saving* (effective as of 28 Aug 2017)
Rp0 - < Rp50 Million	0.00%	0.00%
Rp50 Million - < Rp100 Million	0.50%	0.50%
Rp100 Million - ≤ Rp500 Million	4.00%	4.00%
> Rp500 Million	7.00%	6.00%

\*The Interest Rate calculation method is progressive and minimum balance to get interest is Rp50 Million.

Other Savings and Current Account interest rate are not changed.
