

Kinderjoy Kindergarten “Fun for Everyone” Event Terms and Conditions

Event

1. The Kinderjoy Kindergarten “Fun For Everyone” Event (“Event”) will be held on 13 May 2017 (“Event Date”).
2. This Event will be held at Kinderjoy Auditorium, Main Campus, 221 Jalan Raja Permaisuri Bainun, 30250 Ipoh, Perak Darul Ridzuan (“Kinderjoy Kindergarten”) in collaboration with Standard Chartered Bank Malaysia Berhad (“Bank”).
3. By participating in this Event, participants agree to be bound by all the terms and conditions below.

Eligibility

4. This Event is open to:-
 - a) All parents and children registered with Kinderjoy Kindergarten
