

Credit Card Cashback Acquisition Campaign – January 2018 Terms and Conditions Excerpts

1. The Standard Chartered Bank Malaysia Berhad (“SCBMB or the Bank”) Credit Card Cashback Acquisition (January 2018) Campaign (“Campaign”) will run from 1 January to 28 February 2018, inclusive of both dates (“Campaign Period”).
2. The Campaign is only open to New Customers who apply for and whose applications are approved by the bank for WorldMiles World Mastercard[®], JustOne Platinum Mastercard[®], Platinum Visa Card, and Cashback Gold Mastercard[®] issued by the bank (“SCB Credit Cards”) and maintain all their accounts with the Bank in good standing, without any breach of the terms and conditions or agreements, throughout the Campaign Period, (“Eligible Customers”)
3. "New Customers" mean applicants who have not held any Standard Chartered Bank Malaysia Berhad credit card as principal cardholder within the past 6 months before the applicant's credit card under this Campaign is issued.
4. New Customers whose card accounts are suspended, cancelled, or terminated for any reason during the Campaign Period or within 3 months after the end of the Campaign Period will not be entitled to receive any rewards under this Campaign.
5. To participate in this Campaign, Eligible Customers must apply for any of the SCB Credit Cards listed above during the Campaign Period through either the Bank’s offline channels (i.e. the Bank’s branches, Price Solutions Sales Agents, and any other authorised offline sales channels) or the Bank’s online channel (i.e. through our website, sc.com/my); and have their application successfully approved, all within the Campaign Period; and activate their approved SCB Credit Card within 45 days from the credit card approval date (activation criteria).
6. The Successful Eligible Customers will receive RM128 cashback subjected to terms and conditions as stipulated throughout this document.
7. Only one Reward will be given to each Successful Eligible Customer regardless of the number of SCB Credit Cards applied for and duly approved.
8. The Reward will be credited to the Successful Eligible principal cardholder’s credit card account within 90 calendar days from the last day of the month in which the card was approved.

1. Limited to 1 complimentary item per table, per visit, per card. No split payment is allowed.
2. No minimum spend required.
3. Offer is applicable for dine in only.
4. Payment must be made through any Standard Chartered Bank credit or debit card to enjoy the offer.
5. Offer is subject to any applicable tax, unless otherwise stated.
6. Offer is not exchangeable for cash or other items and cannot be used in conjunction with any other discounts, privileges, promotions, discount schemes, loyalty programmes, discount cards, or vouchers, unless otherwise stated.
7. Offer is valid for same value item or lower value item except for Bar.B.Q Plaza whereby item must be same item or equal in value.
8. For Victoria Station, offer is valid at Klang Valley outlets only.
9. For Dragon-i, Dragon-i Peking Duck, Kenny Rogers ROASTERS and Madam Kwan's, offers are not valid at Genting Highlands.
10. For Dragon-i, Dragon-i Peking Duck, Dragon-i Min Xian Pan Fried Dumpling, Bar.B.Q Plaza, Victoria Station, Azuma Japanese Restaurant, Edo Ichi Japanese Restaurant, Ichi Zen, Sushi Zento, Canton-i, Madam Kwan's, Coffea Coffee, Hui Lau Shan, Mango Cottage, and Simmer Huang, the offer is valid till 30 April 2018.

Petikan Terma dan Syarat Kempen Pemerolehan Cashback Kad Kredit – Januari 2018

1. Kempen (“Kempen”) Pemerolehan Cashback (Januari 2018) Kad Kredit Standard Chartered Bank Malaysia Berhad (“SCBMB atau Bank”) akan berlangsung mulai 1 Januari hingga 28 Februari 2018, termasuk kedua-dua tarikh (“Tempoh Kempen”).
2. Kempen ini hanya dibuka untuk Pelanggan Baharu yang memohon dan permohonannya diluluskan oleh bank untuk WorldMiles World Mastercard®, JustOne Platinum Mastercard®, Platinum Visa Card, dan Cashback Gold Mastercard® yang dikeluarkan oleh bank (“Kad Kredit SCB”). Semua akaun mereka dengan Bank dalam keadaan baik, tanpa melanggar mana-mana terma dan syarat atau persetujuan, di sepanjang Tempoh Kempen (“Pelanggan Layak”).
3. “Pelanggan Baharu” bermaksud pemohon yang tidak memegang sebarang kad kredit Standard Chartered Bank Malaysia Berhad sebagai pemegang kad prinsipal dalam tempoh 6 bulan terakhir kempen ini.
