

# Premium - Privilege Savings Account Gift Campaign Terms and Conditions

#### Campaign

- 1. The Standard Chartered Bank Malaysia Berhad ("SCB") Privilege Savings ("Campaign") is valid from 16 October 2017 31 December 2017 ("Campaign Period"), inclusive of both dates.
- 2. By participating in this Campaign, participants agree to be bound by all the terms and conditions below.

# Eligibility

- 3. This Campaign is open to Individuals who fulfill the following conditions:
  - 3.1. Individuals who has existing or opened a Privilege Saving Account during the Campaign Period and who maintain their account(s) in good standing, without any breach of the terms and conditions or banking agreements, throughout the Campaign Period (hereinafter referred to as "Eligible Account Holders").
  - Permanent and contract employees of SCB and Standard Chartered Saadiq Berhad ("SCSB") are not eligible to participate in this Campaign.

## Interpretation

However, transfers of funds from other current and/or savings ("CASA") account within SCB or SCSB are not considered as Fresh Funds.

#### Gift
