

e\$aver Kids Dash Promotion Terms and Conditions

1. This e\$aver Kids Dash Promotion (the "Promotion") is available from 1 September 2016 to 31 October 2016 (both dates inclusive) (the "Promotion Period"). The Promotion is open to the first two hundred (200) customers who successfully apply for an e\$aver Kids Account offered by Standard Chartered Bank (Singapore) Limited in Singapore ("Standard Chartered" or the "Bank") during the Promotion Period. By participating in the Promotion, you agree to be bound by these terms and conditions.

ELIGIBILITY

2. To qualify for this Promotion, you must satisfy all the qualifying criteria set out below:

e\$aver Kids Sign Up

- a. You must apply for an e\$aver Kids Account (the "Account") as a Trustee (Parent) account holder (the "Trustee") together with a Beneficiary (Child) (the "Beneficiary") account holder (the "Beneficiary") by filling up and submitting the physical application forms available at any of the Bank's branches (the "Branch Application") during the Promotion Period;
- b. Your application for the Account must be one of the first 200 applications approved by the Bank;
- c. You must deposit a minimum sum of S\$15,000 in *fresh funds* (the "Minimum Deposit") into the Account at the time of account opening, where "fresh funds" means funds not originating from an existing account with the Bank and funds that are not withdrawn and re-deposited with the Bank within the last 30 days of opening the Account.
- d. You must maintain the Minimum Deposit in the Account until the end of the calendar month immediately after the calendar month in which the Account is opened, and
- e. Your e\$aver Kids Account must be validly existing (i.e. must not be suspended, cancelled or terminated), in good standing, and conducted in a proper and satisfactory manner at all times, as determined by the Bank in its sole and absolute discretion.
- 3. For the avoidance of doubt, the Promotion is only applicable to the first 200 new applications for an Account approved on or before 31 October 2016. You must not have had a previous Account suspended, cancelled or terminated for any reason, prior to your new application, and subsequently re-open another e\$aver Kids Account for the purposes of this Promotion.

GIFT

If you satisfy the qualifying criteria set out in **Clause 2**, read with **Clause 3** above, you will be eligible to receive a promotional code (the "Gift") which avails you to a one-time complimentary registration for the Beneficiary to register for the Kids Dash Run in the Standard Chartered Marathon Singapore 2016 (the "Marathon"), which would be held on 3 December 2016, subject to these terms.
- 5. Unless otherwise stated, an SMS containing a unique promotional code will be sent to the Trustee account holder's registered mobile number with the Bank within 14 working days of funding the Account with the Minimum Deposit.



- 6. No payment or compensation whether in cash, credit or kind shall be made for any uncollected, unutilised, lost, misplaced, defaced, stolen or damaged Gifts. The Bank is not an agent of the merchants supplying the Gifts or organising the Marathon. The Bank makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Gifts and assume no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in the Gifts and the Marathon. Any dispute about the quality, value, condition or performance of the Gifts and the Marathon shall be resolved directly by you with the merchants. The Bank is not obliged to assist or act on your behalf in communicating with the merchants supplying the Gifts or organising the Marathon for any reason. You accept the Gift as it is and subject to any terms and conditions the merchants may impose.
- 7. If the eligibility requirements set out in Clauses 2 and 3 above were not or have not been satisfied, as determined by the Bank in its sole and absolute discretion, the Bank reserves the right to claw back from any account (without notice to you) the value of the Gift.
- 8. For the avoidance of doubt, each Account holder is entitled to a maximum of one (1) Gift each on a first-come, first-served basis, while stocks last.
- 9. The Gift is not transferable or exchangeable for cash or any other items. The Bank reserves the right to replace or substitute the Gift with any item of equivalent or similar value, without prior notice or reason (and the Bank shall not be obliged to disclose its reason).
- 10. No payment or compensation will be given to the Trustee and/or Beneficiary who fail, for whatever reason, to utilize their promotional code at www.marathonsingapore.com before registration ends for the Kids Dash Run in the Marathon.
