

## Mobile Wallets One for One Deals (8 March to 31 May 2017) Promotion Terms and Conditions

1. This Mobile Wallets One for One Deals Promotion (the "**Promotion**") is available from 8 March to 31 May 2017 (both dates inclusive) (the "**Promotion Period**"), unless otherwise extended or otherwise terminated in accordance with these terms and conditions. By participating in this Promotion, you agree to be bound by these terms and conditions.

## **Eligibility**

- 2. To qualify for this Promotion, you must register or have registered your Standard Chartered Credit, Debit and MANHATTAN card ("Enrolled Card") with Apple Pay, Samsung Pay or Android Pay (singularly "Mobile Wallet", collectively "Mobile Wallets").
- 3. Under this Promotion, you can enjoy the following offers:
  - a. At Spinelli Coffee Company's stores in Singapore:
    - i. A complimentary, regular size Café Latte upon purchase of a regular size Café Latte on your Enrolled Card using any Mobile Wallet; or
    - ii. A complimentary regular size Cappuccino upon purchase of a regular size Cappuccino on your Enrolled Card using any Mobile Wallet; or
  - b. At SaladStop!'s stores in Singapore:
    - i. A complimentary Signature Salad upon purchase of a Signature Salad on your Enrolled Card using any Mobile Wallet.
- 4. The Promotion is valid at all outlets of SaladStop! and Spinelli across Singapore.
- 5. Each customer is eligible for one (1) redemption per visit. The total redemptions made pursuant to this Promotion are limited as follows:
  - a. 16,000 redemptions across all outlets of Spinelli; and
  - b. 1500 redemptions across all outlets of SaladStop!
- 6. The Promotion is only valid for in-store purchases and is not valid for purchases made through the relevant online websites or through the relevant mobile applications (each where relevant).

## General

- 7. We will treat any enrollment of the supplementary card, and any amounts charged to the supplementary card through Mobile Wallets, as transactions on the Enrolled Card by the principal cardholder.

By participating in this Promotion, you consent to the use of your personal data for marketing purposes, including but not limited to the use of your telephone number to contact you about products and promotions offered by the Bank from time to time via telephone, SMS or multimedia messaging. Such consent will supersede any prior choices made by you. Such consent will also prevail even if you are registered or subsequently register your contact information with the national Do Not Call Registry.
- The Bank reserves the right to vary, modify, add or delete any of these terms and conditions, including terminating, shortening, extending or withdrawing the Promotion, without prior notice or reason.

  - a. Eligibility to participate in the Promotion;
  - b. Determining if a Card is to be or has been enrolled on Mobile Wallets; or
  - c. Receipt of any gift under this Promotion,

The Bank makes no warranty or representation as to the quality, merchantability or fitness for purpose of the goods and services bought and accepts no liability for the services provided by any merchant or service provider. Any dispute about the same must be resolved directly with the merchant or service provider.
