Subject: Notify continuation of Safe Deposit Box Service at Thonglor Branch

Ref: Safe Deposit Box Rental Agreement dated <u>DD/MM/YY</u>, Safety Deposit Box No.xx

This is with reference to the announcement on 22 December 2016 whereby Standard Chartered Bank (Thai) PcI (the "Bank"), has entered into an agreement to transfer Retail Banking business to TISCO Bank PLC and All – Ways Co., Ltd, a subsidiary of TISCO Financial Group PCL. The Retail Banking products under such agreement include credit card, personal loans, business loans, mortgage loans, wealth management, bancassurance and retail deposits of the Bank.

Since the Safe Deposit Box Service for Thonglor Branch is included in the business transfer, you can continue to enjoy the service at the branch. Please kindly contact Thonglor Branch to sign the new Safe Deposit Box Rental Agreement with TISCO Bank PLC within 7 August 2017 and enquired you to prepare the copy of important documents to attach with the new contract as follows.

For Thai customers	Identification Card (ID.)
For customer who holding alien card	Alien Certification and House Registration (HR.)
For Resident customers	Passport and Work Permit / Resident Certificate
For Non-Resident customers	Passport

In addition, the Bank is required you to check your properties in the Safe Deposit Box before completing the contract with TISCO Bank PCL. After a new lease agreement of Safe Deposit Box has been signed. The agreement between Standard Chartered Bank and you will be cancelled on the date that the bank has transferred the Retail Business to TISCO Bank PCL which is expected to complete by Q3 2017 and you will be notified accordingly by the Bank. The Bank will process to refund annual fee of safe deposit box – the refund will be calculated on a pro-rata basis. Going forward, you can pay annual fee of safe deposit box with TISCO Bank PCL. Moreover, TISCO Bank PCL will continue to charge annual fee and other fees for the years 2017-2018 at the same rate as previously paid to the Bank. From 2019 onwards, annual fees and other fees will be charged in accordance with the announcement of TISCO Bank PCL, which they will inform you in the next opportunity.



However, if you are unable to contact the Bank within the aforementioned date, <u>your safe deposit box rental</u> agreement shall be automatically terminated and the Bank reserves the right to open the safe deposit box and process as stipulated in the agreement and in accordance with the Bank's procedures.

For Corporate & Institutional Banking and Commercial Banking, the Bank remains committed to serve our clients in Thailand and you can still access our products and services as usual. The Bank values your business and will continue to serve your banking and financial needs.
