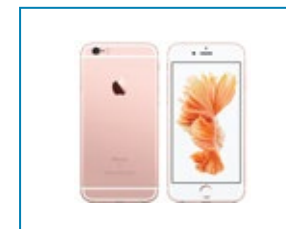

Terms & Conditions

Conditions (For referrer)
