WE PAY – YOU PLAY CAMPAIGN TERMS AND CONDITIONS

The We Pay-You Play Campaign (as part of SCB – SBGR Golf Privilege Program) (the “Program”) is applicable for eligible customers of Standard Chartered Bank (Vietnam) Limited (the “Bank”) with the following terms and conditions:

1. **The Program period and location:** from 01st September 2016 to 31st August 2017, both days inclusive (the “Program Period”). The Program shall be promoted within Ho Chi Minh City during the Program Period.
2. **Eligible customers of the Program:** Priority Customers who open term deposit in VND during the Promotion Period (“Customer”).
3. **Applicable Product:** Term deposit in VND.
4. **Promotion Mechanics:**
 - 4.1 Customer’s deposit must be a term deposit in addition to the aggregated deposits of Customer as at 01 June 2016, and credited to Customer’s account during the Promotion Period.

 - b. **Scheme Birdie:** Customer has to pay Pre-mature withdrawal fee and a promotion fee of VND18,000,000

(equivalent to market price of One (1) Three-month Special Access Golf Programme at SBGR offered by the Bank) at the time of withdrawal.

- c. **Scheme Eagle:** Customer has to pay Pre-mature withdrawal fee and a promotion fee of VND18,000,000 (equivalent to market price of One (1) Three-month Special Access Golf Programme at SBGR offered by the Bank) at the time of withdrawal, and will not receive interest payout.
- d. **Scheme Hole-In-One:** Customer has to pay Pre-mature withdrawal fee and a promotion fee of VND101,280,000 (equivalent to market price of One (1) Package of Golf Term Membership at SBGR offered by the Bank) at the time of withdrawal.

4.5 If Customer early withdraws the term deposit after two (02) weeks from the placement date:

- a. **Scheme Par:** Customer will not receive interest payout.
- b. **Scheme Birdie:** Customer has to pay a promotion fee of VND18,000,000 (equivalent to market price of One (1) Three-month Special Access Golf Programme at SBGR offered by the Bank) at the time of withdrawal.

5. Reward delivery process:

5.1 When an eligible term deposit under this Terms and Conditions is successfully credited into Customer's account at Standard Chartered Bank Vietnam, the Bank will send a "We Pay – You Play Campaign Welcome Letter" ("Welcome Letter") to Customer.

5.2 This Welcome Letter will allow Customer to play golf and enjoy membership rights for the first time visit to Song Be Golf Resort. To continue to enjoy the golf playing benefits, Customer has to register for golf membership with Song Be Golf Resort and with the scheme selected by Customer. 5.4 **For Scheme Par:** Customer has to bring the Welcome Letter to Song Be Golf Resort located at No. 77 Binh Duong Avenue, Lai Thieu, Thuan An, Binh Duong Province, Vietnam in order to receive the offer. Upon verification of the Welcome Letter by Song Be Golf Resort, Customer is entitled to purchase one (1) Three-Month Special Access Golf Program directly at Song Be Golf Resort at a preferential price of VND11,175,000.

5.5 **For Scheme Birdie/Eagle/Hole-In-One:** Customer has to bring the Welcome Letter to Song Be Golf Resort located at No. 77 Binh Duong Avenue, Lai Thieu, Thuan An, Binh Duong Province, Vietnam in order to receive the offers. Upon verification of the Welcome Letter by Song Be Golf Resort, Customer is entitled to register for Golf Term Membership, Social Membership with Song Be Golf Resort at no additional cost.

6. Other provisions

6.1 Customer joining the "We pay- You play" Program of the Bank agrees to pay the Pre-mature withdrawal fee at the Bank's prevailing tariff and/or the relevant promotion fee if Customer early withdraws the deposit as provided in Clauses 4.4 and 4.5 of this Terms and Conditions. For avoidance of doubt, with respect to the

promotion fee, the Bank shall not accept the return of the Gold Membership card that has been given to Customer, but it shall automatically set off such fees against the Customer's term deposit at the time of withdrawal.

- 6.2 This Program is not applicable for any term deposit that has been rolled over to enjoy the offer under this Program and not transferable. Any extension or renewal of Golf Membership Card shall be subject to Song Be Golf Club's terms and conditions.
- 6.3 This Program is applicable for one (01) time only for each Customer. For "Joint account", the offer is accumulated once (01) for the primary account holder.
- 6.4 The Bank will not be responsible for Customer's eligibility for Song Be Golf Resort's membership. Therefore, the Bank highly recommends Customer to refer to Song Be Golf's regulations on membership eligibility from time to time before joining the Program.
- 6.5 The Program rewards are products/services provided by the Banks' suppliers and subject to the terms and conditions of the respective suppliers. Customer is responsible for settlement of all taxes relating to or generating from the rewards. The Bank makes no representation as to the quality of the goods and services provided as the rewards.
