STANDARD CHARTERED HONG KONG MARATHON 2010 FINISHES WITH A CHARITABLE KICK

Organisers announce funds raised for Standard Chartered Marathon Charity Programme; honours winners of Corporate Challenge and SME Marathon Cup

[Hong Kong, 22 April 2010]: The organisers of the Standard Chartered Hong Kong Marathon 2010 today announced that the event raised over HK\$2,800,000 for the three beneficiary organisations of the Standard Chartered Marathon Charity Programme: HK\$1,110,000 for Seeing is Believing (SiB), Standard Chartered's global initiative against preventable blindness; HK\$1,310,000 for the Hong Kong Paralympic Committee & Sports Association for the Physically Disabled (HKPC&SAPD); and HK\$400,000 for the Hong Kong Anti-Cancer Society (HKACS).

Officials also presented awards to the winners of the Corporate Challenge and SME Marathon Cup during the ceremony. Mrs Bethy Tam, Head of Governance & Strategic Initiatives, Standard Chartered Bank (Hong Kong) Limited, expressed gratitude to the business community for their overwhelming support and participation in the Corporate Challenge and SME Marathon Cup.

Mrs. Tam added that this year's race drew a record-breaking number of participants to these two events—216 SME teams and 189 wholesale banking customer teams. KPMG once again had the highest team participation in the Corporate Challenge, and United Controls Limited - Devil Resurrection Team A won the SME Marathon Cup.

"It also reflected Hong Kong's community spirit by unifying the public for a good cause."
