

TERMS AND CONDITIONS FOR ENHANCED TRAVEL PROTECTOR SINGLE TRIP PROMOTION

1. This Enhanced Travel Protector Single Trip Promotion (“Promotion”) is organised by MSIG Insurance (Singapore) Pte. Ltd. (“MSIG Insurance”). The Promotion is valid from 9 April 2015 to 30 June 2015 (“Promotion Period”). Enhanced Travel Protector Policy is underwritten by MSIG Insurance and distributed by Standard Chartered Bank (Singapore) Limited (“SCBSL”).
2. If you purchase a Single Trip Enhanced Travel Protector Policy during the Promotion Period through SCBSL you will be entitled to a 20% discount off your premium where your premium is fully paid. Notwithstanding the above, the minimum premium after discount is \$22.
